SJRWMD REDI COST-SHARE WATER SYSTEM IMPROVEMENTS, PHASE III

Sealed Bids for the construction of the SJRWMD REDI Cost-Share Water System Improvements, Phase III project will be received by the Town of Interlachen, Florida, at the office of the Town Clerk, Interlachen Town Office, 311 Atlantic Avenue, Interlachen, Florida 32148, until 2:00 p.m. local time on Monday, November 5, 2018, at which time the Bids received will be publicly opened and read aloud.

The Project consists of furnishing all labor, equipment, incidentals, and taxes to construct approximately 4,100 LF of 6" PVC water main extensions; install approximately 4 new water services/meters; replace existing 1-1/2" water mains with approximately 1,400 LF of 6" PVC water main conventionally installed, and approximately 2,050 LF of 6" fusible PVC water main installed via directional drill; replace and reconnect approximately 7 existing water services; along with associated valves, fittings, fire hydrants, and connections. Additive alternates, which include additional water main replacements and extensions, may be included in the project based on available budget.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis, with additive alternate bid items as indicated in the Bid Form.

Prospective Bidders may examine the Bidding Documents at the Issuing Office, and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Bidding Documents will be provided on compact disc as portable document format (PDF) files and as printed Bidding Documents (one of each), for a non-refundable charge of \$120 per set, payable to "Mittauer & Associates, Inc." Upon Issuing Office's receipt of payment, the digital and printed Bidding Documents will be sent via UPS Ground. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda, if any, obtained from sources other than the Issuing Office.

Bidding Documents also may be examined at the office of the Town Clerk, Interlachen Town Office, 311 Atlantic Avenue, Interlachen, Florida, 32148 (386) 684-3811.

Bid security shall be furnished in accordance with the Instructions to Bidders.

To be considered qualified, Bidder shall be licensed to engage in the business of contracting in the State of Florida by the Construction Industry Licensing Board and shall have successfully completed, as prime contractor, a minimum of three (3) projects of a similar nature involving water main installation within the past three (3) years each having a minimum contract value of \$250,000 with at least one project having a contract value in excess of \$500,000. In addition, the Bidder or listed Subcontractor shall have completed a minimum of ten (10) drills with 6" fusible PVC in excess of 1,000 LF using electrical wireline guidance systems.
